MINUTES OF THE DDC/ REVIEW MEETING FOR THE MONTH OF APRIL, 2023 HELD ON 18-04-2023 AT 11:00 AM IN THE CONFERENCE HALL, DEPUTY COMMISSIONER'S OFFICE, DIPHU, KARBI ANGLONG.

Members Present :- As per list enclosed (at Annexture-'A').

The meeting was chaired by Smti. Madhumita Bhagoboty, ACS, Deputy Commissioner, Karbi Anglong, Diphu. The meeting is also by Shri Horen Sing Bey, Hon,ble MP, 3-Autonomous Dist.(ST) PC and Shri Bidya Sing Engleng, Hon'ble MLA, 19-Diphu(ST) LAC and Smti. Krishna Baruah, ACS, D.C., West Karbi Anglong Distict and among other members.

At the outset, the Deputy Commissioner welcomed all the members present in the meeting. Initiating the discussion, the Deputy Commissioner instructed that all concerned executing agencies to ensure for timely completion of the sanctioned schemes under MPLAD/ MLAADS/ Untied Fund/ Assam Darshan/ AAGY/ DMFT etc. executed by DRDA/BDOs of Rongkhang/ Lumbajong/ Howraghat/ Langsomepi/ Samelangso/ Bokajan/ Nilip/ Rongmongve Dev. Block and other line departments. so that utilization certificates could be submitted to the Govt. in due course.

After a brief discussion and review, the following decisions were taken:-

- 1. D.C. wanted to know the progress of MPLAD fund and after going through the reports, D.C. directed the representative of BDO, Rongkhang and BDO, Lumbajong Dev. Block to complete all the balance works under MPLADS and asked to submit requisition, U/C & other relevant documents etc. within 1 (one) week so that U/C could be submitted in time to the Govt.
 In this regard, Hon'ble MP urged all concerned Executing Agencies of MPLAD Fund to expedite completion of all the pending works at an early date so that balance amount of MPLAD fund could be released soon by the Govt. of India. D.C., West K/A informed that so far 1(one) No. scheme is 100% completed and rest 12 Nos. are in progress.
- 2. On enquiring about the status of work/progress of schemes under MLAAD'S & Assam Darshan, 2021-22, D.C. directed all concerned BDOs/PD, DRDA to complete all the works/ projects within the month of April, 2023 as new works/projects for the financial year, 2022-23 are to be started soon after receipt of Plan & estimates from the concerned Executing Agencies.
- 3. D.C. directed the all concerned BDOs/ their representatives of Lumbajong/ Howraghat/ Samelangso/ Bokajan/ Nilip Dev. Block to be prepared and get ready for ceremonial foundation stone laying programme in the respective Axom Adarxo Gram Yojana (AAGY) villages to be held on 11th May, 2023 13th May, 2023. D.C. also informed that priority should be given to works relating to Entry Point activities viz.: Village Entry Gate, Solar Street Light, Drinking water facilities, Construction and up-gradation of Schools and Anganwadi Centres/Community Centres/Hall etc.

As regards Bank Account details for schemes under AAGY, D.C. instructed that a new A/C may be opened in the name of Construction Committees concerned, if not yet opened and proceedings of the VLC meeting, new schemes proposals along with Plan & Estimates etc. are to be submitted urgently.

The meeting ended with a vote of thanks from the chair.
