## Minutes of DDC/review meeting held on 10-02-2023 at 3.30 PM in the Conference Hall of D.C.'s Office, Karbi Anglong, Diphu

Members Present:- As list enclosed (Annexure-A).

The meeting was chaired by Smti. Madhumita Bhagoboty, ACS, Deputy Commissioner, Karbi Anglong, Diphu. At the very outset, the Deputy Commissioner welcomed all the members present and then requested for self introduction by the members/officials one by one.

After that, the Deputy Commissioner urged all concerned Executing Agencies/BDOs to complete all on-going/ pending schemes under MPLADS/ MLAADS/ Untied Fund/ Assam Darshan/ AAGY/ PMJVK/DMFT etc. within the month of February, 2023 and submit all pending UCs for onward submission to Govt.

The Deputy Commissioner, then asked Senior Planning Officer to highlight the progress of ongoing schemes under MPLADS year wise executed by the BDOs of Rongkhang/ Lumbajong/ Bokajan Dev. Block/ Rongmongve/PD, DRDA etc.

After a brief discussion, the meeting reviewed the status of on-going schemes as under:

- The Deputy Commissioner instructed the BDO, Rongkhang Dev. to submit all the required/relevant documents as per checklist provided to them against the remaining schemes of MPLADS, 2016-17 (II) to 2019-20 (I) without any further delay.
  - The Sr. Planning Officer informed that about 91 (Ninety-one) No. of Physical Verification Reports(PVRs) under MPLADS executed by the BDO, Rongkhang Dev. Block have been received from D.C., West Karbi Anglong, Hamren and some 29 (twenty-nine) No. schemes sanctioned recently. The Deputy Commissioner instructed the Sr. Planning Officer to process for early release of all schemes, which has balance fund of below of Rs.50,000/-only.
- 2. The Deputy Commissioner directed the PD, DRDA, Diphu to supervise/monitor the works executed by the BDOs from time to time as various schemes are being implemented through Development Blocks apart from MPLADS/MLAADS/Untied Fund etc. for speedy implementation. In a reply, the PD informed that review meetings are regularly held with all the BDOs on monthly basis.
- 3. On a query to the representative of PWD(Bldg.) Deptt., the Deputy Commissioner informed the house that all Heads of Executing Agenecies/Deptts. should attend the DDC/review meeting as may important matters/inter-departmental issues are being discussed here. Henceforth, Executive Engineer, PWD(Bldg.) Diphu Division, K/A may be directed to attend the DDC/review meeting accordingly.
- 4. The Deputy Commissioner directed all concerned BDOs to submit the requisition/ucs & other relevant documents etc. urgently in order to release balance under Assam Darshan schemes.

The meeting ended with a vote of thanks from the Chair.
