

MINUTES OF DDC/ REVIEW MEETING FOR THE MONTH OF MARCH HELD ON 06-03-2023

AT 11.00 AM IN THE D.C.'S CONFERENCE HALL KARBI ANGLONG, DIPHU

Members Present: As per Annexure-'A'.

The meeting was chaired by Smti. Madhumita Bhagoboty, ACS, Deputy Commissioner, Karbi Anglong, Diphu.

At the outset, the D.C. welcomed all the members present in the meeting. Initiating discussion, the D.C. urged all concerned Executing Agencies/officials to expedite completion of remaining works of all ongoing/ pending schemes and submit utilization certificates at the earliest possible for onward submission to the Govt.

After a brief discussion, a review was held on the progress of schemes under MPLADS/MLAADS/Untied Fund/ Assam Darshan(Namghars)/AAGY/PMJVK etc. implemented by the Executing Agencies as follows:

1. D.C. directed Executive Engineer, i/c. representing the PD, DRDA to expedite all the remaining works under MLAADS, 2021-22 and place requisition for release of final installment fund urgently.
2. D.C. directed the BDO, Langsomepi Dev. Block, Bokalia to submit all the pending UCs/Completion reports/Hand over certificates etc. of schemes under MLAADS/Untied Fund/Assam Darshan etc. urgently.
3. D.C. directed all concerned BDOs/ representatives of BDO, Lumbajong/ Howraghat/ Samelangso/ Bokajan/Nilip to hold a VLC meeting in respect of Axom Adarxo Gram Yojana (AAGY) villages for preparation of Village Development Plan(VDP) in consultation with local MLAs concerned at an early date and send the proceedings of meeting, list of schemes/new proposals etc. for the current financial year, 2022-23.
4. On enquiring on slow progress of implementation of schemes under MPLAD, D.C. directed the representative of BDO, Rongkhang Dev. Block to take necessary steps and ensure completion of all pending Schemes as early as possible.
5. D.C. urged the BDOs, Bokajan/Nilip Dev. Block to make an assessment of all the schemes under PMJVK (erstwhile MSDP) and submit requisition along with a status report for release of balance fund urgently. In reply to a query, the BDO, Bokajan Dev. Block informed that demand proposals/requisition of all pending schemes under MLAADS/Assam Darshan etc. will be submitted within March, 2023.
6. D.C. directed all concerned Executing Agencies/PD, DRDA/BDOs/EE, PWD(Building) Diphu Division, K/A to submit all the UCs/Completion Certificates/Assets Hand Over Certificates etc. along with good quality photographs with signboard (preferably HD) against all completed works of MLAADS & Untied Fund, if not submitted yet, for uploading in the e-Rupantor portal, which is directly reflected in the dashboard of HCM, Assam.

Lastly, the D.C. once again urged all Executing Agencies to expedite and ensure for timely completion of ongoing/pending works by end of March, 2023 and submit all relevant documents as instructed earlier.

The meeting ended with a vote of thanks from the chair.
