

Minutes of the meeting held in the Conference Hall, D.C.'s Office, Diphu on 06-01-2022 at 3.00 PM with members of the Governing Council to review and discuss on the Implementation/Utilization of DMFT fund.

Members Present :- As per **Annexure – A.**

The meeting was presided over by Shri Dibakar Nath, IAS, Deputy Commissioner cum Chairman (DMFT), Karbi Anglong, Diphu.


At the very outset, the Deputy Commissioner welcomed Hon'ble members of DMFT present in the meeting and felicitated the Hon'ble MP and Hon'ble Deputy Speaker, Assam Legislative Assembly and MLA, 17-Bokajan (ST) LAC, who attended the meeting as Hon'ble Members.

Initiating the discussion, DC, Karbi Anglong highlighted all the approved list of projects/schemes and its present status under PMKKKY from the DMFT fund till date. After a threadbare discussion, the following key points were recorded in the meeting as follows :-

1. The D.C., Karbi Anglong, informed and emphasize that all the developmental schemes related to PMKKKY/ DMFT fund should be proposed and implemented as per guidelines to the areas affected by mining and mining related activities keeping in mind the interest and benefits of the people is to be sustained.
2. The D.C, Karbi Anglong directed all the Ex. Agency to adopt strategic policy initiatives for smooth functioning and proper utilization of the approved schemes.
3. The D.C., Karbi Anglong requested for taking up Schemes in mining affected areas and submission of proposal from Hon'ble MP/ MLAs as per guidelines for further proceedings from the District authority.
4. The D.C, Karbi Anglong asked all the Executing Agencies and other line departments whether any other support from the District administration is required for smooth conduct while implementing the developmental schemes in mining affected areas.
5. The D.C, Karbi Anglong directed, District Industry & Commerce to collect & submit all list of Small & Large scale industry.
6. The Hon'ble MLA, 17-Bokajan & Dy. Speaker, Assam Legislative Assembly, suggested for taking keen interest in providing sufficient developmental projects only in mining affected areas as per needs of the local people. He further stressed on enhancement of basic needs such as construction of Toilets in Schools, Health Care Centres and distribution of sanitary napkin to the girls students in the affected area under DMFT fund.

7. As per reports received from the PWD (B) Division, Diphu, the D.C informed that 2 (two) Schemes, namely- (i) Const. of Karbi Lammet Amei cum Library Building, Bakalia and (ii) Const. of Assam Sahitya Sabha cum Library building, Bakalia are to be dropped and accordingly the committee members agreed on this.
8. In the meeting, the committee decided that the scheme Const. of Ram Terang Area Gravity Piped Water Supply Scheme" which was kept pending till date is to be executed in the following financial year, 2021-22.
9. The Hon'ble Dy. Speaker lauded that female oriented SHG's should be given priority for taking up any developmental work based in those concentrated areas corresponding their economic livelihoods to be meet.
10. The implementation/execution of projects under PMKKKY scheme should function only as per guidelines of DMFT.
11. The Hon'ble Dy. Speaker instructed for holding quarterly review meeting with all Line Departments and submit all policy measures adopted for final approval to the members committee. He also suggested to raise the fund under CSR for welfare of the people in Karbi Anglong from different small & large scale industries such as ONGC, CCI, Bankers etc.
12. The Hon'ble MP suggested to take up developmental projects in the affected areas with due verification and discussion with local people concerned for their upliftment accordingly.
13. The Hon'ble MP, suggested for taking up safe drinking water schemes under DFMT, where Jal Jeevan Mission(JJM) has not reached in the mining affected areas.
14. The SP, Karbi Anglong suggested for formation of Surrendered Groups from mining affected areas into SHG and provide seed money for Skill development from DMFT fund.

The meeting ended with a vote of thanks from the Chair.


